ELECTED POSITIONS (2-YEAR TERMS)

The Section Director-Elect (Section Director-Elect for 2019, takes office as Section Director in 2020-2021, serves as Past Director in 2022) provides leadership for the Section by coordinating and directing the Board's activities and programs. The Section Director represents and promotes the Section to related organizations, and communicates between the California Chapter Board and the Section. The Section Director conducts Section Board Meetings, oversees the budget, and chairs the Executive Committee.

The Vice Director At-Large (Awards), along with another Vice Director At-Large, directs the Section's annual Awards Program and gala, coordinates award submittals for the California Chapter Awards, and chairs the Awards Committee. This Vice Director also assists with the development and implementation of special projects and activities of the Section Board.

The Vice Director of Administration develops and maintains Section administrative records and operational systems. This Vice Director coordinates updates of the bylaws and guidelines as needed, and implements special projects assigned by the Section Director.

The Vice Director of Policy reviews local, state and federal legislation, develops Section legislative responses, and presents policy items to the Board. The Vice Director maintains a strong working relationship with the Chapter Vice President for Policy and Legislation.

APPOINTED POSITIONS (1-YEAR TERMS)

The Diversity and Inclusion Director prioritizes, promotes, and recruits members to ensure inclusivity and diversity among the Section membership.
